

> 89% of the cases were all or partially legally represented






DISTRIBUTION OF CASES OF CSC



Total No. of questionnaires Distributed: 1014





• 79% of the parties strongly agree/agree CSC had helped to save / reduce litigation costs



- **78%** of the parties strongly agree/agree CSC had helped to avoid tension and conflict in litigation







• 73% of the parties strongly agree/agree CSC had helped party / parties to narrow down the issues to be tried


