## Integrated Mediation Office (West Kowloon) of the Judiciary

The Integrated Mediation Office (West Kowloon) aims to assist the parties to understand what the nature of mediation is and how it helps the parties, in particular those of the Small Claims Tribunal proceedings, resolve their disputes, as well as to facilitate them to seek mediation from the private practitioners or professional bodies outside the Judiciary.

This office answers enquiries and provides information on court-related mediation on all civil cases, especially for those of the Small Claims Tribunal.

#### What is Mediation?

Mediation is an alternative dispute resolution process designed to help parties in dispute reach their own mutually acceptable agreements so as to resolve their differences. It is a voluntary process in which a trained and impartial third person, the mediator, assists the parties to communicate and negotiate issues in a private and confidential setting. During the process, each party to the dispute has a chance to put forward his case and to listen to what the other has to say. The mediator's job is not to make a decision for the parties, but to assist the parties to explore the strengths and weaknesses of their own cases and to identify possible solutions, so as to facilitate the reaching of a settlement agreement. A professionally trained mediator is skilled in breaking negotiation impasses and in keeping everyone focused on finding a solution.

## What are the Advantages of Mediation?

- You may avoid the tension and conflict in the adversarial litigation system
- You may save some time and money in not having to contest the matters in Court
- You make your own decisions and reach agreements with which you and the other party may be more willing and ready to comply
- The settlement terms stated in the mediation agreement can be kept private and confidential
- Mediation may help preserve, and even improve, the relationship between parties
- The terms stated in the mediation settlement agreement can go beyond the legal remedies of damages and injunctions to which the courts are limited

# **Eligible Disputes**

- Civil disputes, including but not limited to water seepage disputes, landlord and tenant disputes, renovation disputes, consumer services disputes, minor personal injuries claims, employment disputes, commercial disputes, goods and services disputes, building management disputes and other disputes
- Dispute amount not exceeding the prevailing maximum claimable amount of the Small Claims Tribunal (currently at \$75,000)

### What's next?

Arrangement will be made for any parties who are interested in seeking mediation and have approached the Integrated Mediation Office (West Kowloon) to attend an information session on mediation. This office will provide the information on court-related mediation service available for the parties and the ways to apply for such service. Information sessions, enquiry services, pre-mediation consultations and mediation services for Small Claims Tribunal cases are provided and arranged by the Integrated Mediation Office (West Kowloon) free of charge.

Please note that a party's application for information or mediation session will not lead to an automatic stay of the legal proceedings, but the party is subject to the Court's direction in this regard.
